

## 1 ADDENDUM #1

The addendum refers to changes and additions to the original Contract Documents and is to be read in conjunction with the same. All other parts of the original Contract Documents are to be considered as applying to the work of this Contract with the exceptions and changes as noted below.**

**WORK:**

- .1 A cash allowance of \$10,000 for the removal of any unsuitable material as determined by the Geotechnical Consultant, which would be deemed extra to the required earthworks, already covered in the Tender Documents.
- .2 A cash allowance of \$1,000.00 for the work indicated on Drawing E1 - Electrical Specification, & Legend, for Specification Note 29c.
- .3 A cash allowance of \$1,000.00 for the work indicated on Drawing E1 - Electrical Specification, & Legend, for Specification Note 34f.

Contractors are advised to carry sufficient overhead and administration cost to administer and coordinate this work.

The undersigned hereby acknowledges that the sum of:

ONE THOUSAND EIGHT HUNDRED DOLLARS - \$1,800.00

Is also included in the total tender amount as a separate amount to cover the cost of the Harmonized Sales Tax (HST) related to the above Cash Allowances.

In the event that the Owner decides not to proceed with any or all of this work, we agree to credit the Contract with the unused portion of the full amount of these Cash Allowances, as applicable, and the related HST.
