#### **EDUCATION ACT**

### SABBATICAL LEAVE REGULATIONS AMENDMENT

Pursuant to section 107 of the *Education Act* R.S.P.E.I. 1988, Cap. E-.02, Council made the following regulations:

1. Subsection 4(1) of the *Education Act* Sabbatical Leave Regulations (EC529/16) is revoked and the following substituted:

#### 4. Eligibility to apply

- (1) A teacher is eligible to apply for sabbatical leave if the teacher is employed by an education authority as instructional personnel under a permanent contract in a full-time teaching position in a school operated by the education authority.
- 2. Section 5 of the regulations is amended by the addition of the following after subsection (5):

#### **Conditional on agreement**

- (6) Notwithstanding subsection (4), a grant of sabbatical leave is conditional on the education authority and the teacher entering into a written agreement regarding the sabbatical leave, which may include
  - (a) terms requiring the teacher to return to service as instructional personnel with the education authority for a period equivalent to three school years following the sabbatical leave;
  - (b) terms requiring the teacher to repay to the education authority all or a portion of the salary paid to the teacher pursuant to clause 7(1)(a) or 7(2)(a) while on the sabbatical leave, if the teacher fails to complete the course of study for which the leave was granted or fulfill the return of service requirements referred to in clause (a); and
  - (c) other terms and conditions as agreed to by the parties.

#### No conflict

- (7) An agreement referred to in subsection (6) shall not conflict with the Act, the regulations or a current collective agreement governing the parties.
- 3. These regulations come into force on August 24, 2024.

#### **EXPLANATORY NOTES**

**SECTION 1** revokes and replaces subsection 4(1) of the regulations setting out the eligibility requirements for a teacher to apply for sabbatical leave.

**SECTION 2** adds subsection 5(6) to the regulations, which makes a grant of sabbatical leave conditional on the execution of a sabbatical leave agreement between the education authority and the teacher and sets out some of the terms it may include. It also adds subsection 5(7) to the regulations, which provides that a sabbatical leave agreement shall not conflict with the Act, the regulations or a current collective agreement governing the parties.

**SECTION 3** provides for the commencement of these regulations.
