PEl Universal EV Incentive Program

Updated Reference Material for Car Dealerships

January 28, 2025

This guide will assist dealerships on the **PEI Universal EV Incentive Program** and what is required to when going through the process.



Information for Dealers:

The Prince Edward Island Universal EV (UEV) Incentive Program is intended to encourage and accelerate clean energy vehicle deployment and technology innovation on Prince Edward Island. The UEV Incentive program is administered and implemented through the Department of Environment, Energy and Climate Action (EECA) and the Department of Transportation and Infrastructure (DTI).

The program provides incentives for Islanders who purchase (a new or used) or lease (a new) Battery Electric Vehicle (BEV) or a Plug-in Hybrid Electric Vehicle (PHEV) from a licensed Island dealership.

Eligible Vehicles:

- For new vehicles: eligible vehicles must qualify for the Transport Canada iZEV program <u>https://tc.canada.ca/en/road-</u> <u>transportation/innovative-technologies/</u> <u>zero-emission-vehicles/light-duty-zero-</u> <u>emission-vehicles/incentives-purchasing-</u> <u>zero-emission-vehicles</u>
- For used vehicles: Vehicles must have a sticker price of \$70,000 or less and must not be older than 7 model years old. For example, 2023 purchase year: 2016 model or newer, 2024: 2017 model or newer, etc.
 This stipulation does not apply to converted EVs purchased from Upcycle Green Technology in PEI.
- As the federal iZEV program is currently paused as of January 13, 2025, the PEI EV incentive program will continue to use the federal list of eligible vehicles, at this time.



Eligible Applicants/Applications must meet all requirements:

- The purchaser/lessee of the vehicle(s) must be an individual, business, public agency or entity (including municipal and First Nations, Indigenous organizations, and organizations that support Indigenous peoples, but excluding provincial, crown, and federal government agencies), or nonprofit organization that is registered in PEI.
- Businesses that are active in the corporate registry, Island municipalities, First Nations, Indigenous organizations, organizations that support Indigenous peoples, and non-profit organizations qualify for five incentives per calendar year.
- Businesses that are inactive for nonpayment in the Business Registry will be ineligible for the UEV Incentive.
- The purchase/lease date must be on April 1, 2021 or after to be eligible for the incentive.
- Proof that each sale / lease of an eligible UEV Incentive was made to a PEI resident (or PEI business operating in PEI with a valid business license or to a public agency in PEI).
- A copy of the sales or lease contract signed by all parties with an itemization of credits, discounts, and incentives received, if applicable.
- A UEV Incentive application and checklist signed and completed by the dealership and/or the purchaser/lessee.
- Modifications are not made or allowed to the vehicle's emissions control systems, hardware, software calibrations, or hybrid system.

- Information on all incentive reimbursement applications and required documentation is submitted to Access PEI in a timely manner.
- The Dealership submitting the application must be a licensed Prince Edward Island dealership.
- Each unique VIN will be eligible for one new and one used EV Incentive. To confirm if a VIN is eligible for an EV Incentive please e-mail: <u>EVIncentive@gov.pe.ca.</u>

To receive a vehicle incentive the vehicle must remain plated, registered and insured in Prince Edward Island in the applicant's name for at least 12 months from date of sale. If before the 12 months is up, the applicant does not abide by all of the conditions listed, the applicant will be required to pay back a prorated amount payable to the Minister of Finance.

The UEV Incentive Program will be administered and implemented through a partnership between the Department of Environment, Energy and Climate Action and the Department of Transportation and Infrastructure. Nothing in the Terms and Conditions or Dealer Information Package changes or supersedes any of the existing requirements of a Dealer's Trade License under the Highway Traffic Act and the associated Dealer's Trade License Regulations

UEV Incentive FAQ

What is the PEI Universal EV Incentive Program?

The Prince Edward Island Universal EV (UEV) Incentive Program is intended to encourage and accelerate clean energy vehicle deployment and technology innovation on Prince Edward Island. The UEV Incentive Program is administered and implemented through the Department of Environment, Energy and Climate Action (EECA) and the Department of Transportation and Infrastructure (DTI). The program provides incentives for Islanders who purchase (a new or used) or lease (a new) Battery Electric Vehicle (BEV) or a Plug-in Hybrid Electric Vehicle (PHEV) from a Licensed Dealership.

As of January 1, 2023 the total incentive for BEVs is \$5000 + \$750 charging incentive = \$5750. For PHEVs the incentive is \$2500 + \$750 charging incentive = \$3250. The program will no longer provide a free level 2 charger, instead a \$750 incentive will be added to go towards the customer's purchase and installation of their preferred charger or towards charging costs for those who may not have the option of installing a charger.

Who is eligible for the incentive?

The purchaser/lessee of the vehicle(s) must be a PEI resident or a non-profit, business, public agency, or entity operating or registered in PEI (including Island municipalities, First Nations, Indigenous organizations, and organizations that support Indigenous Peoples, but excluding provincial, crown, and federal government agencies).

As a business, how many incentives can I receive?

Businesses that are active in the corporate registry, Island municipalities, First Nations, Indigenous Organizations, organizations that support Indigenous Peoples, and non-profit organizations qualify for five (5) incentives per calendar year. Businesses that are inactive for non-payment in the Business Registry will be ineligible for the EV Incentive.

When does the PEI Universal EV Incentive Program start?

The following changes have been made to incentives as of March 1st, 2023 and retroactive to January 1, 2023- 1) Used vehicle incentives increase from a maximum price threshold of \$55,000 to \$70,000 and 2) new vehicle incentives increase to align with the Federal iZEV program eligibility guidelines (https://tc.canada.ca/en/road-transportation/ innovative-technologies/zero-emissionvehicles/light-duty-zero-emission-vehicles/ incentives-purchasing-zero-emission-vehicles).

What documents must be filled out?

Proof that each sale/lease of an eligible UEV Incentive Program was made to a PEI resident (or PEI business operating in PEI with a valid business license or to a public agency in PEI). A copy of the sales or lease contract signed by all parties with an itemization of credits, discounts, and incentives received, if applicable. *Copy of PEI drivers license and copy of vehicle registration are required.*

Are private sales or consignment sales eligible for the Incentive?

No, private or consignment sales are ineligible for the UEV Incentive.

How do I know what vehicles qualify for the incentive?

For new vehicles: eligible vehicles must qualify for the Transport Canada iZEV program. Incentive amounts may differ from the federal program, for example, plug-in hybrids will only receive a \$3,250 incentive, regardless of battery range or size.

For used vehicles: vehicles must have a sticker price of \$70,000 or less and must not be older

than seven years (i.e., 2023 purchase year: 2016 model or newer, 2024: 2017 model or newer, etc.)

Does my EV have to be highway operable?

Yes. The Department of Transportation and Infrastructure or the Department of Environment, Energy and Climate Action may request that a vehicle manufacturer provide a written statement declaring whether or not the vehicle is capable of highway operation. A vehicle will be presumed not capable of operation on the highway if any one of the following circumstances apply:

- the vehicle is a low-speed vehicle;
- the vehicle is prohibited by law from being operated on the highway or is only capable of limited operation on the highway;
- the manufacturer has required, or will require, the purchaser or lessee to sign an agreement that limits, or prevents, the operation of the vehicle on the highway;
- there is a written manufacturer's statement or recommendation (which can include the owner's manual for the vehicle) that the vehicle should not be operated on the highway or should have limited operation on the highway;
- modifications have been made to the vehicle's emissions control systems, hardware, software calibrations, or hybrid system.

How do I receive the incentive and are there any conditions I must follow?

To receive a vehicle incentive the vehicle must remain plated, registered and insured in Prince Edward Island in the applicant's name for at least 12 months from date of sale. If before the 12 months is up, the applicant does not abide by all of the conditions listed, the applicant will be required to pay back a prorated amount of the incentive payable to the Minister of Finance

Who do I contact for more information about the incentive?

The UEV Incentive Program will be administered and implemented through a partnership between the Department of Environment, Energy and Climate Action and the Department of Transportation and Infrastructure. How many times can an EV be incentivized?

Each unique VIN will be eligible for one new and one used EV Incentive. To confirm if a VIN is eligible for an EV Incentive please e-mail: <u>EVIncentive@gov.pe.ca</u>.

PEI Universal EV Incentive Application Checklist

Dealerships - What you MUST submit to Access PEI

Copy of Completed PEI Universal Electric Vehicle Incentive Application -Dealer Information, Purchaser/Lessee Information, and Vehicle Information ALL completed

If the dealership accessing the PEI UEV program does not have a submit a completed Payee Registration Form must be attached with the application, otherwise simply put your VRN on the application form.

Copy of the checklist within the application package – ALL boxes must be checked by dealer AND purchaser/lessee, with signatures from dealer representative and purchaser/lessee (and co-purchaser/lessee, if applicable)

Bill of Sale/Lease Agreement - MUST include a clear line item called "PEI Universal EV Rebate and Charging Incentive"

Copy of a Valid PEI Driver's License – temporary licenses WILL be accepted, however RINs will not. For fleet vehicles purchased/leased by a registered business, organization, or public entity based in Prince Edward Island, the **business number** or other proof entity is required.

Copy of PEI Registration for the purchased/leased vehicle

Note 1: The Vendor Registration Number (VRN) is the number used by government in order to process payment for a dealership accessing the incentive; this number is NOT the RIN OR Business Number. The VRN is obtained by completing a Payee Registration Form, this form only needs to be completed once and then a dealer will be provided their VRN for all future applications. Island Residents that Purchase/Lease from off-island Dealerships

Copy of Completed PEI Universal Electric Vehicle Incentive Application – Basic Dealer Information, Purchaser/Lessee Information, and Vehicle Information Bill of Sale/Lease Agreement

Copy of a Valid PEI Driver's License – temporary licenses WILL be accepted, however RINs will not. For fleet vehicles purchased/leased by a registered business, organization, or public entity based in Prince Edward Island, the business number or other proof entity is required.
