ROADS ACT
HIGHWAY ACCESS REGULATIONS
AMENDMENT

(Approved by His Honour the Lieutenant Governor in Council dated 8 June 2004.)

Pursuant to subsection 29(1) of the *Roads Act* R.S.P.E.I. 1988, Cap. R-15, Council made the following regulations:

1. Schedule C-3, LOCAL (CLASS 3) HIGHWAYS, of the *Roads Act* Highway Access Regulations (EC580/95) is amended by the addition of the following after subsection 1(422):

(422.1) **Ross Road RI53600:** The Ross Road commencing at Route 317, 1.3 km. west of the intersection with Route 17 in the settlement of Sturgeon for a distance of .48 km.

2. These regulations come into force on June 19, 2004.

EXPLANATORY NOTES

The amendment adds to Schedule C-3 the Ross Road, located in the settlement of Sturgeon, as a local unpaved year-round road that the Department maintains on a year-round basis.
