**EC2024-680**

**FIRE PREVENTION ACT  
CODES AND STANDARDS ORDER  
AMENDMENT**

(Approved by Her Honour the Lieutenant Governor in Council dated July 2, 2024.)

Pursuant to subsection 24(2) of the *Fire Prevention Act* R.S.P.E.I. 1988, Cap. F-11, and upon the recommendation of the Minister of Justice and Public Safety, Council made the following Order:

- 1. Clauses 1(a) and (a.1) of the *Fire Prevention Act* Codes and Standards Order (EC16/85) are amended by the deletion of the words “2021 edition” and the substitution of the words “2024 edition”.**
- 2. These regulations come into force on July 13, 2024.**

**EXPLANATORY NOTES**

**SECTION 1** amends clauses 1(a) and (a.1) of the *Fire Prevention Act* Codes and Standards Order (EC16/85) to update to the 2024 edition of the National Fire Protection Association’s NFPA 1 Uniform Fire Code.

**SECTION 2** provides for the commencement of these regulations.
