EMPLOYMENT STANDARDS ACT
MINIMUM WAGE ORDER
AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated September 28, 2023.)

Pursuant to section 5 of the *Employment Standards Act* R.S.P.E.I. 1988, Cap. E-6.2, Council approved the following Minimum Wage Order made by the Employment Standards Board:

1. **Section 1 of the *Employment Standards Act* Minimum Wage Order (EC139/96) is revoked and the following substituted:**
 1. **Minimum rate**

The minimum rate of wages for all employees to whom section 5 of the *Employment Standards Act* R.S.P.E.I. 1988, Cap. E-6.2, applies shall be:
\$15.40 per hour effective April 1, 2024.
 2. **Section 1 of the Order is revoked and the following substituted:**
 1. **Minimum rate**

The minimum rate of wages for all employees to whom section 5 of the *Employment Standards Act* R.S.P.E.I. 1988, Cap. E-6.2, applies shall be:
\$16.00 per hour effective October 1, 2024.
3. (1) **Subject to subsection (2), this Order comes into force on April 1, 2024.**
 - (2) **Section 2 of this Order comes into force on October 1, 2024.**

EXPLANATORY NOTES

SECTIONS 1 and 2 revoke section 1 of the *Employment Standards Act* Minimum Wage Order and replace it with new provisions to set out two adjustments in the minimum wage rate for the year 2024, effective on the specified dates, based on a review by the Employment Standards Board, undertaken in accordance with subsection 5(2) of the Act.

SECTION 3 provides for the commencement of this Order.

TICKET REGULATIONS AMENDMENT

Pursuant to section 10 of the *Summary Proceedings Act* R.S.P.E.I. 1988, Cap. S-9, Council made the following regulations:

- 1. Part 27.1 of Schedule 2 to the *Summary Proceedings Act* Ticket Regulations (EC58/08) is amended in Column III by the deletion of the words “3,000 (individual)” wherever they occur and the substitution of the words “5,000 (individual)”.**
- 2. These regulations come into force on October 7, 2023.**

EXPLANATORY NOTES

SECTION 1 amends Part 27.1 of Schedule 2 to the *Summary Proceedings Act* Ticket Regulations (EC58/08) to specify the amount of the minimum fine for an out of court settlement for summary offences set out in the *Forest Fire Protection Act* R.S.P.E.I. 1988, Cap. F-13.2.

SECTION 2 provides for the commencement of these regulations.
