- (i) All producers who have sold seed potatoes to producers in Prince Edward Island shall report to the Board, in writing, no later than June 30 of each year the volume of seed potatoes sold by such seed potato producers to producers in Prince Edward Island for that crop year, and remit to the Board the levies imposed on such sales pursuant to subsection 3(2);
- (ii) All producers shall disclose to the Board, in writing, no later than June 30 of each year, all purchases of seed potatoes made by such producers from seed producers in Prince Edward Island, including the identity of the seed potato producer from whom seed potatoes were purchased and the volume of such purchases.

The Board may order the audit of the records of any seed potato producer who has sold seed potatoes in Prince Edward Island, and in connection with such audit, may require production from producers who purchased potatoes from such seed potato producer, written proof of purchase. Should the audit conducted by the Board determine greater volume of sales of seed potatoes to producers in Prince Edward Island than disclosed by the seed potato producer, the Board shall issue an invoice to the seed potato producer for the levies payable on the unreported volume of seed potato sales.

EC2020-111

EDUCATION ACT TEACHER CERTIFICATION AND STANDARDS REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated February 18, 2020.)

Pursuant to section 107 of the *Education Act* R.S.P.E.I. 1988, Cap. E-.02, Council made the following regulations:

- 1. Clause 1(1)(d) of the *Education Act* Teacher Certification and Standards Regulations (EC534/16) is amended by the deletion of the words "continued in" and the substitution of the words "continued under".
- 2. Clauses 15(1)(c) and (f) of the regulations are revoked.
- 3. These regulations come into force on April 1, 2020.

EXPLANATORY NOTES

SECTION 1 amends the definition of "Board" in clause 1(1)(d) of the regulations to correct the reference to how the Board is continued under subsection 7(1) of the Act.

SECTION 2 revokes clauses 15(1)(c) and (f) of the regulations. The provisions set out the fees for an application for a temporary permit and for a replacement teacher's license or temporary permit. The provisions are being revoked to align with the Department's preference to not charge the fees.

SECTION 3 provides for the commencement of the regulations.

TOBACCO AND ELECTRONIC SMOKING DEVICE SALES AND ACCESS ACT REGULATIONS AMENDMENT

(Approved by Her Honour the Lieutenant Governor in Council dated February 18, 2020.)

Pursuant to section 9 of the *Tobacco and Electronic Smoking Device Sales and Access Act* R.S.P.E.I. 1988, Cap. T-3.1, Council made the following regulations:

1. Section 1 of the *Tobacco and Electronic Smoking Device Sales and Access Act* Regulations (EC538/15) is revoked and the following is substituted:

"Act", defined

- **1.** In these regulations, "Act" means the *Tobacco and Electronic Smoking Device Sales and Access Act* R.S.P.E.I. 1988, Cap. T-3.1.
- 2. Subsection 2(1) of the regulations is amended by the deletion of the words "subsection 5.1(3) of the Act and clause 1(b)" and the substitution of the words "clause 1(c.1) of the Act".
- 3. (1) Subsection 5(2) of the regulations is amended by the deletion of the words "tobacco, electronic smoking devices or a combination of both are sold or offered for sale at retail" and the substitution of the words "tobacco is sold or offered for sale at retail".
- (2) Subsection 5(3) of the regulations is revoked and the following is substituted:

Cash register sign, tobacconist shop (3) The owner or person in charge of a tobacconist shop shall display on each cash register in the tobacconist shop, within clear view of the cashier, a sign as depicted in Schedule C or a substantially similar sign approved by an inspector.

Cash register sign, other retailer

- (3.1) The owner or person in charge of a place or premises where tobacco is sold at retail, other than a tobacconist shop, shall display on each cash register in the place or premises, within clear view of the cashier, a sign as depicted in Schedule C.1 or a substantially similar sign approved by an inspector.
- 4. Schedules A, B, and C to the regulations are revoked and Schedules A, B, C and C.1 as set out in the Schedule to these regulations are substituted.
- 5. These regulations come into force on March 1, 2020.

EXPLANATORY NOTES

SECTION 1 revokes and replaces the definition section to remove the definition of "tobacconist shop", which is now defined in the Act.

SECTION 2 updates references to provisions respecting a tobacconist shop to reflect amendments to the Act and regulations.

SECTION 3 removes a reference to electronic smoking devices in subsection 5(2) and revokes and replaces subsection 5(3) to reflect that electronic smoking devices are no longer permitted to be sold in a place or premises other than a tobacconist shop.

SECTION 4 updates the text on required signs by revoking and replacing certain Schedules to the regulations to reflect the changes to the age limit in respect of tobacco and electronic smoking devices and that electronic smoking devices are no longer permitted to be sold in a place or premises other than a tobacconist shop.

SECTION 5 provides for the commencement of these regulations.

- **10.1** No person shall discharge a firearm from or within the boundaries of the Roseville Pond Wildlife Management Area.
- **10.2** No person shall hunt, or otherwise molest wildlife in the Roseville Pond Wildlife Management Area provided that nothing in these regulations shall prohibit any person from angling sports fish, in accordance with the *Wildlife Conservation Act* Angling Regulations.
- **10.3** Every person who violates or attempts to violate any provision of these regulations is guilty of an offence and is liable, on summary conviction, to the fines under section 32 of the Act.

EXPLANATORY NOTES

SECTION 1 amends section 1 of Schedule A to the *Wildlife Conservation Act* Wildlife Management Areas Regulations to delete a reference to a map that is not part of the Schedule. The section also amends section 2 of Schedule A by revoking Parcel 22 from the designation of the Forest Hill Wildlife Management Area, substituting a new Parcel 22, and adding new Parcels 23, 24, 25 and 26 to that Wildlife Management Area. The section revokes section 3 of Schedule A, the designation of the lands making up the Glenfinnan Wildlife Management Area, and substitutes a new designation of the lands for that Wildlife Management Area. The section amends section 5 of Schedule A to delete a reference to a plan that is not part of the Schedule. Finally, the section adds a new section 10 to the Schedule to designate the new Roseville Pond Wildlife Management Area, describe its boundaries and area and specify the regulations that apply to it.

SECTION 2 amends section 1 of Schedule B to the regulations to revoke Parcels 2, 5 and 12 from the designation of the Dingwells Mills Wildlife Management Area and substitute new descriptions of Parcels 2, 5 and 12, and to add Parcels 13, 14, 15, 16, 17, 18, 19, 20 and 21 to that Wildlife Management Area. The section also amends section 2 of Schedule B by adding new Parcels 20 and 21 to the Dromore Wildlife Management Area. The section also amends section 3 of Schedule B to add new Parcels 30, 31 and 32 to the Grovepine-Big Brook Wildlife Management Area. The section also amends section 4 of Schedule B to add Parcels 31 to 48 to the Martinvale-Corraville Wildlife Management Area. The section amends Schedule B by adding a new section 6.1 to designate the new Portage Wildlife Management Area and describe its boundaries and area. The section also amends section 7 of Schedule B to add a new Parcel 27 to the Southampton Wildlife Management Area. Finally, the section amends section 8 of Schedule B to delete a reference to an attached sketch that is not part of the Schedule.

SECTION 3 provides for the commencement of the regulations.
